I will maintain full coverage insurance on said item or vehicle while it remains at Stater's Acres RV's. I understand that said dealer assumes no responsibility for damage or loss for this unit, while on consignment. I realize that item or unit may be road tested or demonstrated. I give Stater's Acres RV's permission to road test, demonstrate item or unit as may be necessary to prospective sale. Any and all damage that may result from the road tests or demonstrations is fully my responsibility and not that of Stater's Acres RV's.

A PDI (Pre Delivery Inspection) will be made at time of sale to insure complete proper operation of item or unit. The cost of the PDI is the seller's responsibility. All repairs needed and their additional charges are seller's responsibility. Item or unit must be fully functional at time of delivery. All charges will be deducted from sale proceeds, unless they supersede profit amount. In such cases, seller will pay before item or unit is delivered. PDI hourly charges are as follows and will be charged at dealer's current shop rate:

Pop Ups .....2 Hours      Fifth Wheels .....3 Hours  
Travel Trailers .....3 Hours      Motor Homes .....4 Hours

As owner of the above item or vehicle, I also agree to pay the dealership a \$500.00 minimum or 10% from \$0 to \$50,000; 5% from \$50,000 to \$100,000; or 3% over \$100,000 of the total gross sale, whichever is greater, along with any expenses incurred during th consignment or sale. I give permission to maintain this unit with fuel and necessary repairs to accommodate demonstrations and sale. There will be a \$50 charge for consignment.

Should owner change his/her mind and wish to terminate this contract before the consignment period ends, storage for the time the unit was kept in full monthly increments will be charged, and all repairs or maintenance items must be paid before unit can be removed from dealership.

This agreement is valid for Ninety (90) days from: \_\_\_\_\_. Should me seller wish to continue past this date, he/she may do so provided dealership agrees to an adjusted sale price. Otherwise a \$3.00 per day storage fee, in addition to any commissions will be charged until the sale is consummated or item is removed from dealership.
